### **Yashhtej Industries (India) Limited Commences Revenue Generation from 5 MW Solar Power Project under PM-KUSUM Scheme**

The scheme has been launched for implementation of feeder level solarisation under Component C of the **PM-KUSUM Scheme**.

Pursuant to the said LOA, Maharashtra State Electricity Distribution Company Limited (MSEDCL) shall purchase the electricity generated from the Project, in accordance with the terms and conditions of the Power Purchase Agreement (PPA) executed pursuant to the LOA.

The Company had initiated the process for setting up the 5 MW Solar Power Plant following the award of the LOA. **We are pleased to announce that the project has now commenced operations and has begun generating revenue from 7th March 2026.**

This milestone marks an important step in the Company’s growth strategy and reinforces its commitment towards sustainable energy development and contribution to India’s renewable energy initiatives.
